### WAIVER, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS

I understand that attendance at dog classes or other Club activities is not without risk to myself, members of my family, guests who may attend, or my dog, because some of the dogs to which I will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care.

I hereby waive and release West Los Angeles Obedience Training Club ("Club"), its members, trainers, officers, directors and agents from any and all liability of any nature, for any injury or damage which my family members, my guests, myself, or my dog may suffer while attending any training session or other function of the Club, or while on the training grounds or the surrounding area thereto as a result of any action by any dog, including my own.

I also understand that it is my personal responsibility to maintain control of any dog in my care and custody while attending any training class or Club function. If a dog attacks and bites another dog or human, either during a WLAOTC activity or while coming to or leaving one, it may be immediately expelled from that event. The incident will be reviewed by the Board of Director and if deemed appropriate, the dog will be permanently dismissed from all WLAOTC activities. Once permanently dismissed, the dog will not be permitted to return. It is understood that in signing this form agreement with the waiver is in effect for 16 months.
