

## NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

## DIRECTIONS

**Traveling south on the 405:** Take Exit 54 (Olympic/Pico exit) and turn left onto Sawtelle Blvd. Take the 1<sup>st</sup> left onto Pico Blvd. Travel east for 1.9 miles and turn right onto Motor Ave. Take the 1<sup>st</sup> right into the park on Recreation Center Driveway.

**Traveling north on the 405:** Take Exit 53A (National Blvd) and turn right onto National. Take the 1<sup>st</sup> left onto S. Sepulveda Blvd to Pico. Drive 1.7 miles to Pico and turn right. Travel east for 1.9 miles and turn right onto Motor Ave. Take the 1<sup>st</sup> right into the park on Recreation Center Driveway.

**Traveling west on the 10:** Take Exit 5 (National Blvd) onto Manning Ave. Stay on Manning for 1.5 miles until you reach Pico. Turn right on Pico until you reach Motor Ave (.9 miles). Turn right on Motor and take the 1<sup>st</sup> right into the park on Recreation Center Driveway.

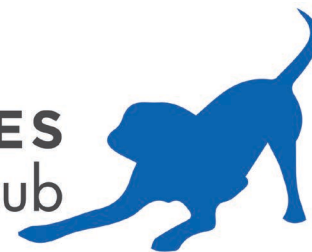

**PRIZES & AWARDS:** Placement rosettes or ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score, and Jr Handlers in Standard.

**Jump Heights – no dog will jump lower than 4”**

P-Card = Permanent Card: the lowest allowable Regular height a dog may jump in CPE.

**General CPE rules for entries/show site:**

- Dogs must be at least 15 months or older the first day of the trial
- Blind (both eyes), lame, in season, or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the Wednesday prior to the trial for Day of Show entries. Registration can be completed on-line at <https://www.cpe.dog>. CPE ID numbers are emailed to on-line registrants.
- Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½” of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.
- Only CPE Judges can measure dogs.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. No relieving of dogs in the warm-up area.

**Dogs in the ring, leashes, exiting the ring**

- Dogs can now run with or without a collar. Collars should preferably be quick release style, and may be a flat buckle, rolled leather, or flea prevention. No attachments of any kind are allowed on the collar
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.
- Handlers may carry their leash with them on the course – if done so, the leash must be out of sight or clipped around the waist or shoulders.
- Dogs must be under the handler’s control when leaving the ring or the judge may enter the run as No Time - NT.

**Training a dog in the ring during a run**

WLAOTC will offer Declared Training In the Ring (TIR). The handler has the option to use a toy or training aid at any time during their run. However, the handler must approach the Judge during Walkthrough or previously in that trial day for the Judge to approve the toy or training aid for use on the course.

- Handler must alert the Judge upon entry to the ring that the dog will be TIR. Handler is then allowed to have a reasonably sized silent toy/aid with them for use once their run has started. (This toy must be approved by the Judge of record PRIOR to the start of the class to determine its eligibility. Absolutely no food/scents/audible devices will be allowed.) The toy is NOT allowed to be used in either gate chute or prior to the previous dog leaving the ring.

See the online rulebook or current member letter for additional rules.

The following items *are* considered training in the ring (see Fix and Go):

- Violating the 4 paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games.

**While running on course**

- The handler will direct the dog through the course without a collar or lead.
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10’ feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5 fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be, but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report will be filed with CPE. See Faults, Eliminations and Excusals in the rulebook.
